#### **B.E.-CYBER SECURITY**

- 1. The Lecture hour of 'Digital Fundamentals and Communications' subject in the III semester has been changed as Lecture 3 hours, Tutorial 1 hour and Credit 3 [i.e. 3 1 0 3].
- 2. Offered 'Software Quality Management' subject instead of 'Total Quality Management' in the Elective IV list for the VII Semester of B.E.-Cyber Security.

#### B.Tech.- ARTIFICIAL INTELLIGENCE AND DATA SCIENCE

- 1. The Elective III subject 'Big Data Framework' in Sixth semester is moved in Elective IV subject and the Elective IV subject 'Introduction to Cloud Computing' is moved to Elective III subject, since, it is available in the same semester Elective subject as 'Big Data Analytics' as Professional Core Course.
- 2. The syllabus of the Third Semester subject 'Basics of Artificial Intelligence and Data Science' has been modified with few basic topics and the title of the subject have been changed to 'Computational Intelligence Essentials'.
- 3. The topics in the Professional Core subject 'Python for Data Science' and 'R Programming in Data Science' are refined in order to avoid no duplication of topics.
